No. 321 AN ORDINANCE IN AMENDMENT OF AND IN ADDITION TO CHAPTER 2000-14 OF THE ORDINANCE OF THE CITY OF PROVIDENCE APPROVED JUNE 23, 2000, ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR THE NINTH (9TH) WARD REDEVELOPMENT PROJECT" FOR THE ACQUISITION OF PROPERTY.

Approved June 29, 2001

Be it ordained by the City of Providence:

That Chapter 2000-14 of the Ordinance of the City of Providence, approved June 23, 2000, entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Ninth (9th) Ward Redevelopment Project be and the same is hereby amended as follows:

- A. Add the following lots to the acquisition list in section 7.1 entitled "List of Proposed Acquisition" which is part of the aforementioned Ordinance:
