No. 285 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1981-9, APPROVED MARCH 13, 1981, BY TRANSFERRING THE SUM OF TWELVE THOUSAND, FIVE HUNDRED DOLLARS FROM LABORER'S INTERNATIONAL LEGAL FUND (1-11-06-338) TO CITY COLLECTOR-TEMPORARY POSITIONS (1-02-05-002).

Be it ordained by the City of Providence:

SECTION 1. Chapter 1981-9 of the Ordinances of the City of Providence, as approved March 13, 1981 entitled: "An Ordinance Making an Appropriation of One Hundred Thirty-Nine Million, Three Hundred Sixty-Four Thousand, Eight Hundred Seventy-Six Dollars (\$139,364,876.00) for Fiscal Year Ending June 30, 1981", as amended, is hereby further amended by transferring the sum of Twelve Thousand, Five Hundred Dollars (\$12,500.00) from Laborer's International Legal Fund (1-11-06-338) to City Collector-Temporary Positions (1-02-05-002).

SECTION 2. This Ordinance shall take effect upon its Passage.

Dear Mr. Rider:

The attached listing is the schedule of the collection of water, real, personal property, excise and supplemental taxes during the period of March, 1981, through May, 1982. This schedule includes the two annual real estate tax sales that will occur during this fourteen month period.

At my present staffing level of 18, it will be impossible for this office to process the 200,000 plus additional tax bills generated by the supplemental levy.

I am therefore requesting that seven (7) temporary positions be allocated to the Office of City Collector, commencing Monday, April 20, 1981; these positions would be paid at a Clerk II level (\$175 per week). Temporary employees have no regular City paid benefits.

An appropriation of \$12,250 would be required to fund these positions during the remainder of this fiscal year, with an additional \$44,100 required during the next fiscal year. The temporary staffers would be employed only through February, 1982, when the final payment of the supplemental tax bill is due.

Should the volume of tax bills reach such a level that certain and/or all of the temporaries become superfluous, they would be terminated, either permanently, or left to be re-hired at the time when the volume of the bills become such that additional staff would be required.

The collective bargaining agreement with the union allocates a three week vacation annually for all regular city employees with one year or more service. The temporary staffers would be of invaluable assistance during the summer months to cover for the regular employees vacations during the collection periods.
