Approved February 12, 1976

WHEREAS, Hugh J. Smith, Sr. has been called to his eternal reward, following a long and effective career in Boy's Clubs activities in the State of Rhode Island, the Commonwealth of Massachusetts and the State of Ohio, and

WHEREAS, from his inception into this service, beginning in 1912 and spanning two thirds of his life, Mr. Smith enjoyed an unenviable reputation with the Members of the many Boy's Clubs he directed, and

WHEREAS, Hugh's ability to win the confidence of the youngsters, who frequented Boy's Clubs, was accepted as a pattern of Director-Club Members relationship, and

WHEREAS, notably amongst his landmark contributions were his long affiliation with the Wanskuck Boy's Club, where he served for more than one quarter of a century and was revered by all the youngsters who frequented that facility,

NOW, THEREFORE, BE IT RESOLVED, that in mourning the passing of Hugh J. Smith, Sr., whose residency in the City of Providence spanned forty years of his life, the Members of this City Council pause in its deliberations and offer their prayers for his eternal repose, and
