RESOLUTION OF THE CITY COUNCIL

No. 5

Approved January 13, 1978

WHEREAS, on July 7, 1977, the Traffic Engineer rescinded "No Parking Between Signs" on the Southerly Side of Kenyon Street, beginning at a point Ninety-Four Feet West of the Westerly Curbline of Pallas Street and extending Westerly for Thirty-Eight Feet, as a result of a Petition submitted by the residents of the area, and

WHEREAS, the Signs were removed as a result of said Petition and approximately One Month later, were installed again at that same location,

NOW, THEREFORE, BE IT RESOLVED, that in accordance with that second Petition submitted by the residents of the area, in protest, together with a communication to His Honor the Mayor, said residents being of the opinion there is no justification for such Signs, the Traffic Engineer is hereby urgently requested to remove the existing "No Parking Between Signs" on the Southerly Side of Kenyon Street, beginning at a point Ninety-Four Feet West of the Westerly Curbline of Pallas Street and extending Westerly for Thirty-Eight Feet.


