
Dear Honorable Members:

Award-winning writer and editor with strong background in editing, writing, public policy, advocacy and management seeks full-time or part-time communications position.

Freelance writer for a number of media outlets, including *East Side Monthly*, *Providence Business News*, *edible Rhody*, *South County Life Magazine*, *Newport Daily News*, *South County Independent* and *Beverage Magazine* (Rhode Island and Connecticut) and for such for-profit and nonprofit clients as Bryant University, the University of Rhode Island, Jewish Family Service of Rhode Island and Temple Beth-El.

As executive editor (effective October 2009) of niche newspaper for greater Rhode Island's Jewish community, had sole responsible for all aspects of production, including supervising the work of a graphic designer, an ad representative and several freelance writers, columnists and graphic designers. I developed themes for issues; stories and edited every story, column and letter to the editor that appeared in the paper; oversaw layout; coordinated production and delivery with outside vendors and managed the budget.

Key accomplishments in first year as editor:

- Produced the paper within budget – the first editor in several years to do so – with no prior training or experience in managing a newspaper or newspaper staff
- Realized a 38 percent increase in dollars donated to our annual patron campaign and a 28 percent increase in the number of patron donors participating
- Increased by 84 percent the number of published letters to the editor and guest opinion pieces
- Selected a less expensive, more efficient and superior printer
- Retained a new designer who provided a new and improved Web site
- Maintained readership numbers, despite an aging target population
