AMENDING SECTION 13-44 OF THE CODE
OF ORDINANCES ENTITLED
"REINSPECTIONS BY DIRECTOR"

Approved January 16, 2004

Be it ordained by the City of Providence:

SECTION 1. The Code of ordinances of the City of Providence is amended as follows:

Sec. 13-44. Reinspections by director.

At the end of the time period specified in a compliance order or any extension thereof, it shall be the duty of the director to make a reinspection of the dwelling, dwelling unit, rooming unit, dwelling premises or structure, and if the order has not been complied with, the director shall institute proper legal action or make such further orders as the case may require. In addition, the cost of any re-inspection shall be borne by the property owner and shall be payable to the City of Providence as follows:

Compliance with first order _____ \$0

First incident of non-compliance with second order

\$75.00

Second incident of non-compliance with third order

\$100.00


Third or subsequent incidents of non-compliance with fourth order

\$200.00

Additionally, any incident of Non-compliance resulting in Notice of intent to
condemn will result in a fine of \$500.00

SECTION 2. This Ordinance shall take effect upon its passage.




At the end of the time period specified in a compliance order or any extension thereof, it shall be the duty of the director to make a reinspection of the dwelling, dwelling unit, rooming unit, dwelling premises or structure, and if the order has not been complied with, the director shall institute proper legal action or make such further orders as the case may require. In addition, the cost of any re-inspection shall be borne by the property owner and shall be payable to the City of Providence as follows:

<u>Non-compliance with fourth order</u>	<u>\$200.00</u>
<u>Non-compliance resulting in Notice of intent to condemn</u>	<u>\$500.00</u>
