<i>Agenda Item</i>	<i>Department Response</i>
1. Petition from Dante J. Giammarco, 55 Dorrance Street, Providence, Rhode Island 02903, dated April 22, 2013, requesting to abandon a portion of Beach Avenue.	This Department is not in favor of this abandonment due to the potential extension of the bike path to this location.
2. Resolution Requesting the Traffic Engineer to cause the installation of a "Do Not Park" or "Do Not Block Driveway" Sign in front of 33 Pocasset Avenue. 3.	A Work Order has been created for this work.
4. Resolution Requesting the Traffic Engineer to cause the inspection of Elmhurst Avenue for the purpose of making one side (opposite Saint Pius School) "No Parking on School Days" between Eaton Street and Fair Oaks Avenue.	The street is sufficiently wide enough so that there is no public safety issues with vehicles parked on both sides of the roadway. On street parking promotes traffic calming.
5. Resolution Requesting the Traffic Engineer to cause the installation of a "15 Minute Parking" Sign in front of the Atwells Avenue Mini Mart located at 196 Atwells Avenue.	That location is within the intersection of Atwells Ave and Dean Street and any parking, regardless of the time restrictions, within an intersection is not recommended.
7. Resolution Requesting the Traffic Engineer to cause the installation of "No Parking Anytime- Dead End Area" Signs in front of 52 Riverdale Street.	This work has been completed.
8. Resolution Requesting the Traffic Engineer to cause the installation of a "Dead End" Sign on Amsterdam Street.	This work has been completed.
9. Resolution Requesting the Traffic Engineer to cause the installation of the missing "Stop" Sign on Covell Street at Atwells Avenue.	This work has been completed.

10. Resolution Requesting the Director of Public Works to cause the installation of speed humps along Carleton Street.	This request has been submitted to the Traffic Calming Review group.
11. Resolution Requesting the Traffic Engineer to cause the installation of a "No Parking" Sign at the curbing across the street from 226 Atwells Avenue and to the left of Messenger Street.	The Atwells Ave Pedestrian Safety Improvement Project has been awarded and will resulting in significant changes to the street. Due to the loss of other on-street parking, additional parking restrictions are not warranted at this location.
