




RE: **Establishment of Energy Task Force**

As you are aware, the City Council adopted an Ordinance on July 25, 2005 relating to Renewable Energy Resources. The Ordinance included a Renewable Energy Goal that states in part: "The City of Providence shall, starting in fiscal year 2010, purchase at least 20% of the energy it consumes annually from clean, renewable sources.

Section 3 of the Ordinance provides for the Establishment of Energy Task Force that "shall consist of 7 individuals, three of whom shall be appointed by and serve at the pleasure of the City Council". I have received a communication (copy enclosed) from the Environment Council of RI recommending three people for consideration for these three positions.

In as much as these appointments are by the City Council, I would like to determine if any Council members have any other candidates they would like considered for the task force.

Please contact Tom Glavin in the Council Office with the names of any individual(s) you would like considered or for additional information. I would like to schedule the matter of filling these positions at a forthcoming meeting of the City Council.

Thank you again for your leadership in bringing clean energy to Providence. The City of Providence is now authorized to form the Clean Energy Task Force pursuant to Ordinance no. 355, which will require 20% of the city's energy to come from clean, renewable sources by 2010. We are very much looking forward to getting started in making the plan to bring your ordinance to its fruition.

The Environment Council of Rhode Island is pleased to announce the nomination of its representative to the Clean Energy Task Force as well as three individuals interested in being appointed by the City Council for service on the Task Force.

Chris Wilhite has been chosen to represent the Environment Council. Mr. Wilhite also serves as ECRI's representative to the Rhode Island Renewable Energy Fund Advisory Board and is the Energy Campaign Organizer for Clean Water Action.

As the City Council considers its own nominees, we would like to recommend three especially outstanding potential task force members: Janet Keller (Ward 13), Aden Van Noppen (Ward 1), and William Space (Ward 1) for appointment to the Task Force by the City Council. Ms. Keller is the Strategic Planning and Policy Chief for the Rhode Island Department of Environmental Management. Ms. Van Noppen is a student at Brown University. Mr. Space is a graduate student at Brown University and a member of the Sierra Club of Rhode Island's Executive Committee.

No. 355

AN ORDINANCE

RELATING TO CLEAN
RENEWABLE ENERGY
RESOURCES

Approved July 29, 2005

Be it ordained by the City of Providence:

SECTION 1. Renewable Energy Purchasing Goal: The City of Providence shall, starting in the fiscal year 2010, purchase at least 20% of the energy it consumes annually from clean, renewable sources. The City shall begin to make renewable energy purchases in the fiscal year 2006, increasing its renewable purchases over time so as to achieve the 20% goal.

SECTION 2. Satisfaction of 20% Goal: The City shall achieve the 20% requirement by using renewable energy as defined in Section 39-26-5 of Rhode Island General Laws. The City need not produce such energy itself, but may satisfy the 20% goal by purchasing Renewable Energy Credits.

SECTION 3. Establishment of Energy Task Force:

1. The City shall establish an Energy Task Force to study the scenarios by which the City could meet the 20% by 2010 goal, including the investigation of funding opportunities and the creation of clean energy installations.
2. The Energy Task Force shall consist of 7 individuals, three of whom shall be appointed by and serve at the pleasure of the City Council, three of whom shall be appointed by and serve at the pleasure of the Mayor, and one of whom shall be chosen by and represent the Environment Council of Rhode Island.
3. The Energy Task Force shall meet as often as necessary, but shall meet once within 90 days of the passage of this ordinance, and at least once each quarter until the implementation plan for the 20% by 2010 goal is completed.
4. Six months after passage of this ordinance and every six months thereafter the Clean Energy Task Force will file a final report detailing its recommendations made towards the 20% by 2010 goal to the City Council for consideration. The Energy Task Force shall continue to meet and file reports as described above until it is discontinued by ordinance.
5. City departments, agencies and their staff shall cooperate with the Energy Task Force by providing them with relevant documents and information in a timely manner.
6. This Ordinance shall take effect upon passage.
