



"AN ORDINANCE REGULATING THE SALE AND DELIVERY OF TOBACCO PRODUCTS TO, AND THE PURCHASE AND USE OF TOBACCO PRODUCTS BY, MINORS"

SECTION I

(1) Legislative Findings, Declaration and Legislative Intent.

(A) The City Council of the City of Providence expressly finds and declares that

1. Cigarette smoking is dangerous to human health;
2. There exists substantial scientific evidence that the use of tobacco products causes cancer, heart disease and various other medical disorders;
3. The Surgeon General of the United States has declared that nicotine addiction from tobacco is similar to addiction to cocaine, and is the most widespread example of drug dependence in this country.
4. The Director of the National Institute on Drug Abuse concluded that the majority of the three hundred twenty thousand (320,000) Americans who die each year from cigarette smoking became addicted to nicotine as adolescents before the age of legal consent;
5. The National Institute on Drug Abuse found that cigarette smoking precedes and may be predictive of adolescent illicit drug use;
6. The present laws in the State of RI prohibiting the sale and use of tobacco products have not been totally effective in preventing such persons from using tobacco products.
7. Experts agree that the leading cause of death and disease in Rhode Island is tobacco use. About two thousand (2,000) people, one-fifth of all deaths in Rhode Island, die from tobacco-related disease every year.
8. The enactment of this Ordinance directly pertains to and is in furtherance of the health, welfare and safety of the residents of the Town of Providence, particularly those residents under eighteen (18) years of age.
9. The RI General Assembly, in 1996, declared that the use of tobacco by Rhode Island children is a health and substance abuse problem of the utmost severity. The legislature found that tobacco product usage by children in RI is rampant and increasing with over thirty percent (30%) of high school students smoking. The present law prohibiting the sale of tobacco to children is being ignored by many retailers. Rhode Island tobacco retailers illegally sell four million eight hundred thousand (4,800,000) packs, over eleven million dollars (\$11,000,000) in tobacco product sales, to children annually.
10. The United States Congress found that for the past twenty (20) years the tobacco industry advertising has been targeting children as the replacement smokers for the one thousand one hundred forty-five (1,145) adults who die daily from tobacco product usage. Approximately seventy percent (70%) of the RI high school seniors who are smoking today will be addicted adult smokers of tomorrow.
11. As a result of this egregious indiscretion, several States, including Rhode Island, have reached a multi-billion dollar settlement with the tobacco companies, of which \$1.4 billion dollars has been allocated to the State of Rhode Island over the next twenty-five (25) years. The first payment to Rhode Island may be received in 1999.
12. According to the Federal Centers for Disease Control and Prevention (CDC),

smoking-related direct medical costs in RI in 1990 climbed to one hundred eighty-six million dollars (\$ 186,000,000). This is an ongoing, escalating financial burden borne by every business, large and small, and every person, smoker and nonsmoker in RI. This is a health and economic drain created by each new generation of children who begin using tobacco products and become addicted to nicotine.

13. Most United States health experts agree that use of tobacco products by minors is the most important public health issue of modern times.
14. The RI Department of Health reports that in 1997, of the 37 over-the-counter tobacco sales sites and the 40 licensed tobacco vending machine sites in North Providence, only twenty (20) compliance checks were conducted to determine vendor compliance with the State Law prohibiting the sale or distribution of tobacco products to individuals under eighteen (18) years of age. North Providence was found to have a violation rate of thirty-five percent (35%), eight percent (8%) higher than the statewide average.
15. To improve the compliance rate among tobacco retailer in Providence and to inform unsuspecting parents of minor children who smoke, a program monitored by the Town of Providence is warranted.

It is therefore the intent of this Ordinance to preserve and protect the health of the children of Providence by (1) stopping or reducing the illegal sale of tobacco products to, and the illegal use of tobacco products by, children, (2) penalize those who disregard the laws relating to the illegal sale of tobacco products to, and use of tobacco products by, children, and (3) inform parents that their minor children are violating state law by engaging in the use of tobacco products.

(2) Definitions

- (A) For purposes of this Chapter the following words and phrases shall have the meanings respectively ascribed to them:
 1. "Tobacco Products" means any substance containing tobacco leaf; including, but not limited to, cigarettes, cigars, pipe, tobacco, snuff, chewing tobacco or dipping tobacco.
 2. "Vending Machine" means any mechanical, electric or electronic self-service device, which, upon insertion of money, tokens or any other form of payment, dispenses tobacco products.
 3. "Tobacco Retailer" means any store or other entity that is licensed to sell tobacco products either over the counter, through a vending machine
 4. "Ground," shall include, but not be limited to, all buildings, grounds and facilities, including ad school buses and field trips, which are under jurisdiction of the school committee.
 5. "Use of Tobacco Products" shall include, but not be limited to, actual smoking, holding or displaying of cigarettes, cigars, pipes, tobacco, snuff, chewing tobacco, dipping tobacco, etc. whether they are lighted or not.

SECTION II

- (1) In accordance with the provisions of Rhode Island General Law 11-9-13, the Providence Police Department will conduct compliance checks on all Providence tobacco retailers. The Police will conduct no less than two compliance checks per year per retail establishment. More than two compliances checks may be conducted a twelve-month period if there is reason to believe that the additional compliance checks are warranted.

The enforcement of this Ordinance shall be by way of the imposition, by the Providence Police Department, of the penalties set forth in Rhode Island General Laws Section 11-9-13.13 or penalties in the following amounts:

First Offense:	\$250.00 Fine
Second Offense:	\$500.00 Fine
Third Offense:	\$1,000.00 Fine

- (2) The Providence School Department will be responsible for the local enforcement of the provisions of Rhode Island General Law 23-20.9, which prohibits the use of tobacco products on school grounds. The Department will include this policy in the student handbooks and all parents of children attending Providence Schools will be provided with a copy. This policy will include the following penalties for violation of the provisions of this Ordinance and General Law 23-20.9:

First offense:

- 1. Confiscate all reasonably accessible tobacco products in the unlawful possession of the offender
- 2. Notify the offending person's parent(s) or legal guardian(s) of the Infraction.
- 3. A one day to three day in-school suspension to the offender and/or require therapeutic assistance*. Such assistance will be made available
- 4. Present him or her with a copy of the Town Ordinance and/or the school policy on smoking on school property.
- 5. The student shall be provided with information concerning the harmful effects of smoking and may be required to perform a service to the school or community.
- 6. The conference with the parent or guardian may be conducted over the telephone but must be held within three days of violation.

Second offense:

- 1. Confiscate all reasonably accessible tobacco products in the unlawful possession of the offender.
- 2. Notify the offending persons parent(s) or legal guardian(s) of the infraction.
- 3. Two day in-school suspension for the offending person from school and/or require therapeutic assistance*. Such assistance will be made available.
- 4. A letter sent home to the student's parent or guardian to be signed and returned to the principal.
- 5. The student may be required to perform community service.

Third and subsequent offenses:

- 1. Confiscate all reasonably accessible tobacco products in the unlawful possession of the offender.
- 2. Notify the offending person's parent(s) or legal guardian(s) of the infraction.
- 3. Three day in-school suspension to the offending person from school and require therapeutic assistance will be made available.
- 4. Letter sent home to the student's parent or guardian to be signed and returned to the principal.
- 5. The student may be required to perform community service

Fourth and subsequent offenses:

1. Referred to the governing body of the school district for disciplinary action letter sent home to the student's parent or guardian to be signed and returned to the principal.

*School Department officials may allow a student of the Providence School System who is found to be in violation of the provisions of this ordinance and/or General Law 23-20.9 to perform community service in addition to, or in place of, all or part of the assigned out of school suspension

SECTION III: Sever ability

- (1) That all ordinance and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed his Ordinance is to be enforced in conjunction with any prevailing State or Federal laws.
- (2) If any paragraph or section of this regulation is found to be illegal, against public policy, or unconstitutional, said ending shall not affect the legality of any remaining paragraph(s), provision(s) or section(s) in force

SECTION IV: Effective Date
