

Statement and Application to serve on PERA: Providence External Review Authority

It has been a rewarding experience working with community organizations in Providence. Through volunteer work at Direct Action for Rights and Equality, Youth in Action, St. Theresa's Church, the Cambodian Society of Rhode Island, The Laotian Association of Rhode Island, the Providence Youth-Student Movement (PrYSM), Jobs with Justice, and Hmong United, I have been able to connect to a large number of community leaders and activists. It has been even more rewarding to connect to the residents, workers, youth, and families in Providence. For example, by initiating a voter-registration drive in the Hmong community, I have been able to connect to hundreds of Hmong families and youth who live in Ward 9.

As part of PERA, my greatest strength is connecting with and advocated on behalf of the youth in Providence. Through PrYSM, I have been fortunate to build strong relationships with Native American, Black, Latino, Asian, and White. I have gained experience working with the Southeast Asian community and the Gang Unit of the Providence Police Department. Through PrYSM, we have been able to affect the lives of hundreds of youth. Our goal is to get them off of the street and into community service, activism, and the arts. The results have been tremendous, as we have connected disaffected youth with quality jobs, and turned gang leaders into community activists. My involvement in working with Southeast community organizations, the police, youth, and gang members has given me both an inside and outside perspective to the issues surrounding juvenile delinquency, crime, police enforcement, as well as police brutality.

Ultimately my previous work with youth, crime, and the police has given me an understanding about how issues of law enforcement, crime, and police misconduct are a multi-racial problem, specifically affecting those individuals and communities who are the most disenfranchised. I am excited to not only be a liason to the Southeast Asian community, but also the African American, White, Cape Verdean, African, Latino, Caribbean, and Central American communities of Providence. Efforts at restoring democracy and order need to be resolved collectively with consideration for all the immigrants, refugees, families, youth, and community organizations that make Providence one of the most exciting, family-centered, and productive cities in the U.S.
