RESOLUTION OF THE CITY COUNCIL

No. 602

Approved September 22, 1977

RESOLVED, DECREED AND ORDERED:

That the following portion of named street as shown as cross-hatched area on the accompanying Plan entitled, "Providence, R.I., P.W. Dept. - Engineering Office, Street Line Section, Plan No. 064024, dated August 23, 1977",

viz:

Portion of Robin Brook Road, from Dorothy Avenue to Hagan Street, depicted on the above noted and accompanying plan as cross-hatched area, having ceased to be useful to the public and the same is proposed to be abandoned as a public highway; subject to twenty (20) foot sewer easement as noted on copy of accompanying plan of the Department of Public Works, and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, that the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

ORDERED, that after the entry of this order or decree, the City Clerk shall cause a notice, thereof, to be published in a newspaper published in the County of Providence at least once a week for three successive weeks, and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

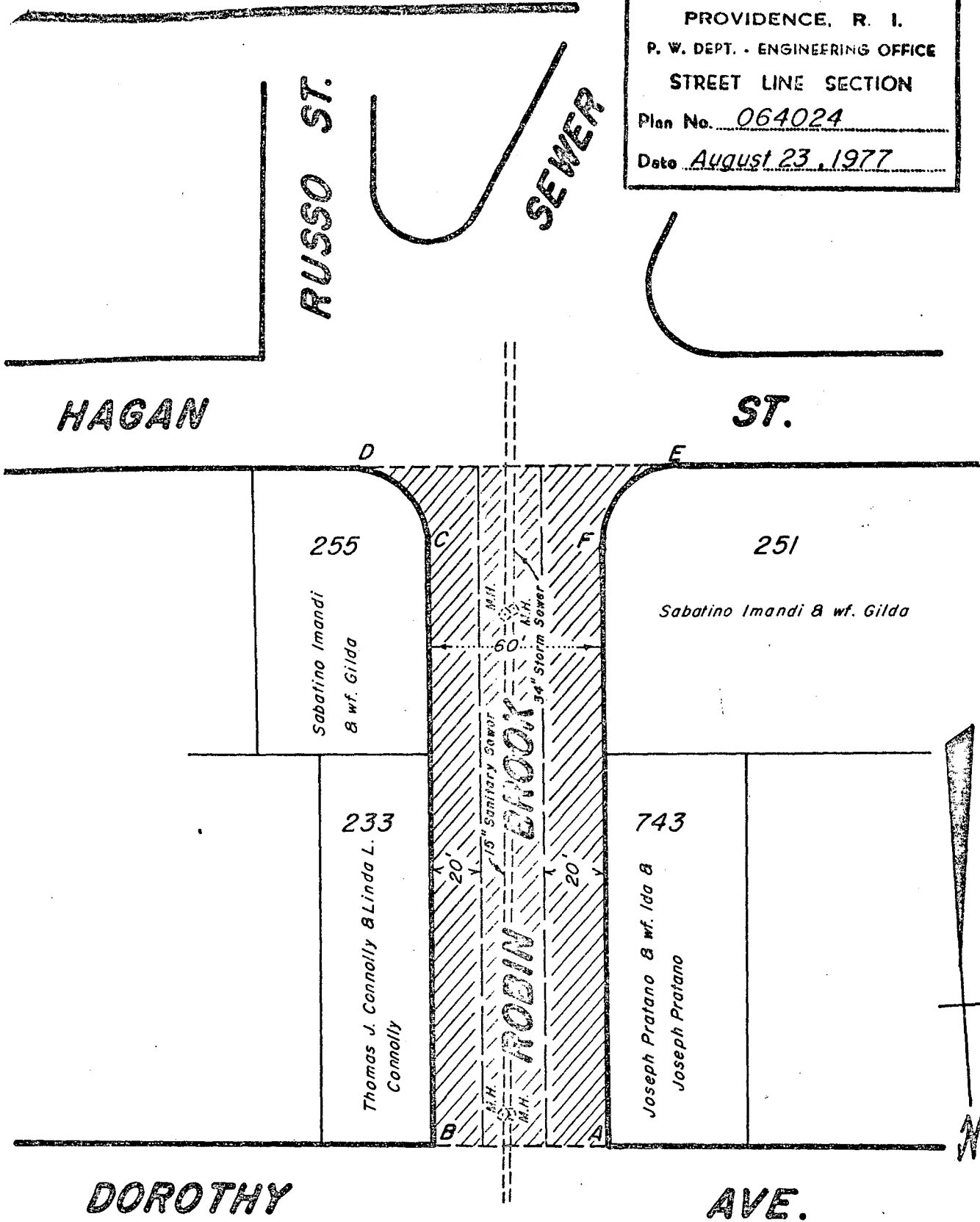


On August 9, 1977 this department received copies of petitions

I have reviewed the proposed abandonments of the following streets and have no objection to any of them:

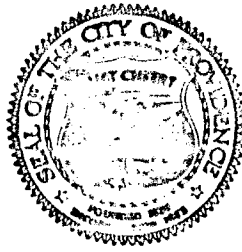
