


It is enacted by the General Assembly as follows:

1 SECTION 1. Section 43-2-5 of the General Laws in Chapter 43-2 entitled "Publication
2 and Distribution of Acts" is hereby amended to read as follows:

3 **43-2-5. Distribution of copies of proceedings.** — The joint committee on legislative
4 services shall, as soon as possible after publication of the general laws, public laws, acts of a local
5 and private nature, and resolutions as provided in section 22-11-3.3, transmit bound or electronic
6 copies to ~~each of the following~~ officers, libraries, or societies as deemed appropriate by the joint
7 committee on legislative services. The bound or electronic copies shall be transmitted by the
8 recipients to their successors in office.

9 (a) One copy each to the governor, lieutenant governor, justices of the supreme, superior,
10 family and district courts, general treasurer, state controller, the director of each state department,
11 administrator of the division of public utilities and carriers, tax administrator, director of business
12 regulation, ~~the several town and city clerks, the several boards of canvassers and registration, the~~
13 ~~several probate courts where the clerk of the court is other than the city or town clerk, the several~~

8 Washington, D.C., the state libraries of the several states, the senate committees on judiciary,
9 finance and commerce, housing and municipal government, the house of representatives
10 committees on judiciary, finance and corporations, the legislative council and the house of
11 representatives, finance committee advisory staff, each member of the general assembly, the
12 associate justice of the Supreme Court of the United States assigned to the First Circuit, each
13 district judge of the United States for the District of Rhode Island, the United States district
14 attorney for the District of Rhode Island, the United States Marshal, the referee in bankruptcy for
15 the District of Rhode Island, and the clerk of the United States District Court, as assigned to the
16 First Circuit, each district judge of the United States for the District of Rhode Island, the United
17 States district attorney for the District of Rhode Island, the United States Marshal, the referee in
18 bankruptcy for the District of Rhode Island, and the clerk of the United States District Court;
19 ~~(b) Four (4) copies to the Secretary of State of the United States;~~
20 ~~(c) Two (2) copies each to the state library, the state law library, the secretary of state,~~
21 ~~the attorney general, the public defender, the Legal Aid Society of Rhode Island, the Rhode~~



WHEREAS, widespread distribution of the annotated General Laws of Rhode Island is a benefit to the State and its citizens.






