Resolution Requiring the full share of Pilot Monies from the proposed FY20 State of Rhode Island Budget.

WHEREAS, Forty Four Percent (44%) of the City of Providence's real estate is owned by institutions that are exempt from paying taxes; and

WHEREAS, The City of Providence serves as the host community to four major nonprofit institutions of higher education: Brown University, Johnson & Wales University, Providence College and the Rhode Island School of Design; and

WHEREAS, The assessed value of the property owned by the four tax exempt institutions in Providence is One Billion Seven Hundred Sixty Six Million Five Hundred Ninety Two Thousand Eight Hundred Dollars (\$1,766,592,820); and

WHEREAS, The proposed FY20 State of Rhode Island budget cuts the State's payment in lieu of taxes (PILOT) funds to the City of Providence by Four Million Ninety Seven Thousand Two Hundred Sixteen Dollars (\$4,097,216) in the upcoming fiscal year; and

WHEREAS, As co-sponsored by both Council President Matos and Council President Pro Tempore Correia, the City of Providence requires its full share of PILOT monies to avoid imposing upon Providence's citizens and taxpayers the cost of providing essential services.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council hereby requests that the General Assembly take all necessary steps to restore to the State's payment in lieu of taxes (PILOT) to twenty-seven percent funded and restore the reduction in PILOT monies of Four Million Ninety Seven Thousand Two Hundred Sixteen Dollars (\$4,097,216) in the upcoming fiscal year to the City of Providence.

BE IT FURTHER RESOLVED, that the Providence City Clerk transmit forthwith a copy of this Resolution to the Governor and to the members of Providence's legislative delegation in the Rhode Island General Assembly.

Resolution Recognizing May 13th through May 20th as "National Infrastructure Week.

WHEREAS, The week of May 13 through 20, 2019, is observed as Infrastructure Week nationally and by the City of Providence; and

WHEREAS, Infrastructure Week 2019 has been established to highlight infrastructure investment needs, and to recognize and encourage leadership at the federal, state, and local levels; and

WHEREAS, Infrastructure Week challenges policy-makers and the public to address the challenges facing U.S. infrastructure, to move beyond short-term fixes and deferred maintenance, and to envision the innovative solutions, technologies, policies and investments that will improve America's infrastructure future.

NOW, THEREFORE, BE IT RESOLVED, That the Providence City Council, as co-sponsored by both Council President Matos and Council President Pro Tempore Correia, and the City of Providence officially recognizes the week of May 13th, 2019 as Infrastructure Week, and urges the citizens of the City of Providence join in this special observance with appropriate events and commemorations.

COUNCILWOMAN RYAN

Resolution Endorsing and Urging Passage by the General Assembly of Senate Bill 2019 S-410 and House Bill 2019 H-5671, An Act Relating to Health and Safety - Plastic Waste Reduction Act.

WHEREAS, The City of Providence passed a single-use plastic bag ban in April 2019; and

WHEREAS, This resolution, sponsored by Council Majority Leader Jo-Ann Ryan, seeks to exclude the uniformity clause from the bills proposed in the State legislation which allows for the distribution of thicker, single-use plastic bags, and will strengthen the intention of the ordinance which was to reduce the amount of plastic bags in circulation overall; and

WHEREAS, Plastic pollution has been recognized as a global crisis, dangerous to the health of our, ocean species, environment and wildlife, contributes to climate change, puts Rhode Island's fishing industries and aquatic ecosystems at risk, human health at risk and is the major component of litter; and

WHEREAS, Bills proposed in both Rhode Island Senate (SB 410) and the House of Representatives (HB 5671) called "Plastic Waste Reduction Act" have been proposed to help eliminate single-use plastic bags; and

WHEREAS, We, the members of Providence City Council, applaud the intent of these bills to reduce the amount of plastic pollution in our State, in our environment, in our ocean and waterways and in our single landfill; and

NOW, THEREFORE, BE IT RESOLVED, The Providence City Council supports these bills provided the uniformity clause is excluded or they are amended so as to compliment municipal plastic-bag reduction ordinances already in place.

BE IT FURTHER RESOLVED, That, upon passage, copies of this resolution be sent to the City of Providence's State Senators and State Representatives in the Rhode Island General Assembly, the Senate President, the Speaker of the House, the City of Providence's Mayor Jorge Elorza, the Executive Director of the Rhode Island Leagues of Cities and Towns, the Governor of the State of Rhode Island and specifically to the municipalities of Barrington, Warren, Bristol, Portsmouth, Middletown, Newport, Jamestown, South Kingstown, North Kingstown and New Shoreham as well as Westerly, Cranston and Providence, all municipalities with uniform and consistent plastic bag bans (some pending) and to the remaining Cities and Towns in the State of Rhode Island.

Resolution Ceremonially Designating Eddy Street between Thurbers Avenue and Rhodes Street, "Prince Hall Way".

WHEREAS, Prince Hall, a prominent citizen in Boston, Massachusetts, founded the African Lodge of Free and Accepted Masons of Boston, the world's first lodge of black Freemason; and

WHEREAS, This was the creation of the first society in American History aimed at the social, political, and economic improvement of African-Americans in the United States; and

WHEREAS, Prince Hall established African Lodges in Boston, Philadelphia, and Providence; and

WHEREAS, He was dedicated to advancing the rights of blacks, the end of slavery, and educational equality; and

WHEREAS, As such, Prince Hall is considered the "father of African Freemasonry" to this day; and

WHEREAS, Upon his passing, his brethren created the African Grand Lodge, which declared its independence from the United Grand Lodge of England and all other lodges in 1827; and

WHEREAS, In 1847, the African Grand Lodge was re-named to Prince Hall Grand Lodge in honor of Prince Hall; and

WHEREAS, In Providence, the Prince Hall Grand Masons Lodge of Rhode Island was established in 1808; and

WHEREAS, The Most Worshipful Prince Hall Grand Lodge of Rhode Island Jurisdictions, Inc., is a fraternal organization founded upon ideals of liberty, equality and peace; and

WHEREAS, The organization is dedicated to taking good men and building and developing them to be better men; and

WHEREAS, They dispense charity, promote good and solid family values, and endeavor significantly to aid in the uplifting of humanity; and

WHEREAS, Their community outreach is diverse and spans the gamut of service from birth to seniors, such as providing books and clothing for children at the Roger Williams Day Care Center, partnering with the Rhode Island Blood Center for Sickle Cell Awareness and Bone Marrow Donor Drives, providing scholarships to students, and collecting shoes to send to the Republic of Congo; and

WHEREAS, It is a fitting to honor Prince Hall and the Prince Hall Grand Masons Lodge by ceremonially designating Eddy Street Between Thurbers Ave and Rhodes Street "Prince Hall Way".

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence does hereby honor Prince Hall and the Prince Hall Grand Masons Lodge of Rhode Island by naming Eddy Street Between Thurbers Ave and Rhodes Street, "Prince Hall Way".

Resolution Requesting to abandon a portion of Fones Alley.

RESOLVED, DECREED, AND ORDERED:

That the following-named street shown on a cross-hatched area on the accompanying map Entitled "Prov., RI, DPW-Engineering Office, Street line Section Plan No. 064857 dated February 19, 2019."

VIZ: Fones Alley (portion of) as described in Attachment "A" and shown as a cross-hatched area on the accompanying plan and designated by the letters A-B-C-D-A, having ceased to be useful to the public and is proposed to be abandoned as a public highway. Said abandonment is specifically conditioned precedent upon the following:

(1) The Petitioners agree to tender the amount of Ninety-one Thousand Three Hundred and Twenty Five dollars (\$91,325) in legal tender U.S. currency to the City of Providence.

(2) The petitioner shall convey an easement acceptable to Verizon which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation.

(3) The petitioner shall convey an easement acceptable to the Narragansett Electric Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation.

(4) Petitioner shall have a Class I survey prepared by a Professional Land Surveyor, properly licensed by the Board of Registration for Professional Land Surveyors, inasmuch as road abandonments constitute a boundary change pursuant to Informational Bulletin 2003.01 issued by said Board.

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.
