**Resolved,**

**That** the City Council of the City of Providence hereby accepts a deed from the State of Rhode Island and Providence Plantations, acting through the Division of Parks and Recreation in the Department of Public Works, pursuant to the authority contained in an Act known as H-688, passed by the General Assembly during the January Session, 1956, and approved March 23, 1956, for nominal consideration in the sum of One (\$1) dollar, said property being fully described in said deed and containing approximately 264,443 square feet of land.

Said area includes Lot No. 13, Assessor's Plat 76, Tax Assessor's Office, City of Providence, and adjoins the Esek Hopkins Junior High School and Leonard's Pond. Said area includes the area shown on a map entitled "Providence, R. I., P. W. Dept., Engineering Office, City Property Section, Plan No. C61285, date October, 1955." Said conveyance is accepted subject to a reverter to the effect that the property shall be used by the City of Providence only as a public park and recreation ground, and in the event of abandonment by the City of such use, the title to the property shall revert to the State of Rhode Island and Providence Plantations.
