





RE: SNOW STREET - ONE WAY

Request: Resolved, that Snow Street, from Weybosset Street to Chapel Street be re-established as a one way street.

Disposition: Snow Street was a one-way street as approved per Ordinance No. 783, dated December 18, 1964. The street was returned to a two-way street on a temporary basis at the request of the parking garage located in this block. While having Snow Street two-ways in this area is convenient for drivers exiting the garage, I feel that due to sight restrictions at the intersection of Weybosset Street and Snow Street, that Snow Street be returned to a one-way street from Weybosset Street to Chapel Street.
