

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, July 25, 1961

This referral is a request for the study, report and recommendation concerning the proposed abandonment as a public highway of a portion of Camp Street beginning at a point at the intersection of the center line of Camp Street and the northerly line of Olney Street and thence running northerly 261.02 feet more or less to a point at the intersection of the center line of Camp Street and a prolongation of the southerly line of Carrington Avenue.

Reference is made to Referral No. 1151, dated June 15, 1960, at which time "It was determined on an inspection and photographic survey that the portion of the street in question was curbed and paved and both sides of the street were marked for demolition.

The segment of Camp Street from Doyle Avenue to Olney Street has been included in the Lippitt Hill Redevelopment Project and a relocation of the southerly portion of Camp Street from Carrington Avenue to Olney Street is proposed to open up land for institutional purposes."

At that time the Commission offered no objection to that petition.

On June 2, 1961 we received an official memorandum from the City Clerk's Office on the subject entitled "Abandonment - Portion of Camp Street".

On May 6, 1960 we forwarded to you a letter that contained the following:


"In the docket of the City Council for May 5, 1960, there is a petition for the abandonment of Camp Street between Olney St. and Carrington Ave. This department has a 24" feeder in this portion of Camp St. which supplies a large area in the East Side section of the city.

On March 24, 1959, this department approved a plan submitted by the Providence Redevelopment Agency entitled "Public Utilities Plan - Water Service - Exhibit No. H - Map No. 6".

Under the circumstances, we object to the abandonment at this time of that portion of Camp Street until the feeder main is relocated as shown on the Public Utilities Plan of the Redevelopment Agency."

I believe that recently the Providence Redevelopment Agency awarded a contract for the installation and relocation of mains on the Lippitt Hill Project to Campanella and Cardi Construction Company. Under no circumstances, should that portion of Camp Street be abandoned until the feeder main is relocated as shown on the plan of the Redevelopment Agency.






