PERSONAL EXPRESSION

COUNCILMAN CLARKIN requests the Privilege of the Floor to Speak on a Point of Personal Expression and states:

"Recently, we had the Courts confirm the Council's right to approve or reject Union Contracts, but there is a catch to this. Police and Fire have Binding Arbitration and unless we go to Arbitration with facts and figures to support our case, we will lose.

I've said in the past that our Fire Department is overmanned and I stand by that statement. We have 539 Firefighters on our Fire Department. That's 3.4 Firefighters for every 1,000 in population. Boston has 1,571 Firefighters. That's 2.7 Firefighters for every 1,000 in population.

Boston, a City with massive traffic jams, tunnels under the streets, rivers, housing stacked together in most neighborhoods, on-street parking and high rise buildings that we could put half of our Downtown in. Boston has all these detriments, all these problems that impede movement in the City and they still have less firefighters per 1,000 population than we do. If we could just cut back to Boston's 2.7 Firefighter, we would save \$5,350,000.00 each year. In five years, we would save the equivalent of the whole Fire Department for this year. We would save \$26,750,000.00. Millions that could go to improve our neighborhoods, millions that could support recreation in our Neighborhoods.

Presently, we spend just a little over \$1,000,000.00 on Recreation. We have over 35 Thousand kids between the ages of 5 and 18 in this City. Can you imagine if we put another \$5,000,000.00 into Recreation of Educational Programs? If we want to stop the waste in this City, we can't just say no. We need the facts to back us up. We need a Management Study and we need to act before the Union Contracts are negotiated."

COUNCILWOMAN WILLIAMS requests to Speak on a Point of Personal Expression and states:

"Madam President, I would like to speak along the same lines in terms of saving money for the City and I refer to the Article in the newspaper this week regarding the Union's objection to the lock boxes. Back in 1992 when I proposed a lock box for collections for the taxes in order to gain interest on the checks which previously would sit in the Collector's Office for days before it went to the bank, I was told that the Union might object. So, time went by and nothing happened. Then by some miracle the Finance Department instituted a lock box which was great news! But, to my dismay, I read this past week in the Providence Journal that the Union is opposed to this action. I hope that the Union President will sit down and discuss the issue rationally with the Administration. The fact that the Administration has instituted this practice in encouraging. We need to earn money any way we can. To lose interest on tax bill money does not make sense. The City can not afford this loss. Common sense is needed in managing City business and the Union should not tie our hands when we try to save Taxpayers money and I want to thank Councilman Glavin for the letter he sent to the President of the Union, Joe Virgilio and I hope that he adheres to that letter in which it is requesting that the President of the Union speak with the Administration to try to resolve this. We need to save money. What good is it to have people working in the Tax Collector's Office, when we don't have the money to pay for them. They have to understand that we need to save money. It is certainly not going to cost thousands and it is certainly a more efficient way and it does not sit on someone's desk. So, that disturbed me greatly when I read that article. I just wanted to properly address this and express my concern. Thank You."

Whereas, Not only did the Fraternal Order of Police criticize Chief Gannon, but called for a vote No Confidence among their union people, and

Whereas, Since the incident has taken place and the call for Chief Gannon to resign, has prompted a coalition of support from various religious and community groups commending Chief Gannon in calling for a full investigation into the recent televised beating of a minority male by a Providence policeman, and

Whereas, There are some members of the Council who feel that Police Chief Gannon did the right thing in suspending the police officer.

Now, therefore, be it Resolved, That we the members of the City Council, Kevin Jackson, Balbina A. Young, Patricia K. Nolan, Ronald W. Allen and John Rollins do hereby support Police Chief Bernard E.
