Dear Ms. Mendonca:

In answer to your request on the telephone this morning, on September 27th, 1978 retroactive to August 21, 1978 pursuant to the consent decree of the Superior Court in C. A. File # 78-269 Ms. Joanne Ferguson was promoted to Deputy Zoo Director (a grade 30 position) and one bird and animal handler slot was left vacant to retrieve all but \$3813. of the needed funds. It is possible that even this amount can be further reduced but since as a result of labor agreements

I presently have two workers on the zoo payroll who refuse to work with animals as an unnecessary curatorial slot required by the consent decree, I really cannot guarantee this. Since the matter is complex, I would be glad to come and testify if it would be helpful.

In regard to Triggs Memorial Park, the rent is \$12/year plus 31% of the gross fees collected and the 15 year lease expires March 28, 1983. The rent is being accumulated in a special account by the Board of Park Commissioners and will be spent on capital improvements at Triggs after it has been doubled with Federal funds.
