Resolved,

That

His Honor the Mayor be and he hereby is authorized to execute a lease to The Great Atlantic and Pacific Tea Company, Inc. of land and buildings at Fields Point, Providence, R. I., now occupied by said company under lease, the new lease to be for five (5) years, beginning April 1, 1963, at an annual rental of FORTY-ONE THOUSAND FIFTY-EIGHT (\$41,058) DOLLARS, the lessee to have options to renew for three successive periods of five years each, the rental for the first renewal period to be at the rate of FORTY-FIVE THOUSAND FIVE HUNDRED FIFTY-EIGHT (\$45,558) DOLLARS. The rental for each of the next succeeding five-year periods shall be subject to agreement between the parties. Said lease shall provide that in addition to the rents, the lessee shall pay the existing two (\$2) dollar car charge up to a maximum of FIVE THOUSAND (\$5,000) DOLLARS annually. The lease shall contain further terms and conditions as may be approved by His Honor the Mayor and the City Solicitor.




AREA SHADED RED TO BE LEASED TO THE GREAT ATLANTIC & PACIFIC TEA CO.

AUTHORIZING THE BOARD OF TRUSTEES OF STATE COLLEGES TO TRANSFER TO THE PROVIDENCE REDEVELOPMENT AGENCY TITLE TO CERTAIN LAND AND BUILDINGS WHICH WAS FORMERLY OCCUPIED BY THE HENRY BARNARD SCHOOL, SITUATED IN PROVIDENCE, RHODE ISLAND

WHEREAS, the State, with the cooperation of the Providence Redevelopment Agency and the New York, New Haven and Hartford Railroad, has engaged in a project to permit the greater beneficial development of a civic center to serve the State and the State Capitol and has developed tentative plans calling for the relocation of the New York, New Haven and Hartford railroad tracks and the Union Station in downtown Providence; and

WHEREAS, the aforesaid railroad relocation, in conformance with the Downtown Master Plan of Providence as approved by the State administration and the Board of Trustees of State Colleges requires the availability of certain land now owned by the State and occupied by the site of the former Henry Barnard School; and

WHEREAS, the successful economic development of the State and the City of Providence is in part dependent on the effectuation of the said railroad relocation project; and

WHEREAS, the implementation of the railroad relocation project will make available land for necessary city, state and federal office space which would otherwise be lacking; and

WHEREAS, the effectuation of the said railroad relocation project will provide space for a centrally located civic center to serve the residents of this State.

IT IS ENACTED BY THE GENERAL ASSEMBLY AS FOLLOWS:

Section 1. The Board of Trustees of State Colleges is hereby authorized to transfer title to so much of the aforementioned tract or parcel of land and all buildings and improvements thereon as may be necessary to make available land for the relocation of Union Station, the tracks used in conjunction therewith and such roads or highways as may be necessary to effectuate the railroad relocation project to the Providence Redevelopment Agency, which said tract or parcel of land is more particularly described as follows:

That certain parcel or tract of land with all buildings and improvements thereon situated in the City of Providence, Rhode Island, bounded and described as follows:

Beginning at the northeasterly corner of the tract herein described; said corner being the intersection of the southerly line of Hayes Street and the southwesterly line of Francis Street;

thence, running along said southwesterly line of Francis Street two hundred eighty two and $\frac{26}{100}$ (282.26) feet to the intersection of said southwesterly line of Francis Street and the northwesterly line of Caspee Street;

thence, turning an interior angle of one hundred twelve degrees, twenty five minutes, thirty seconds ($112^{\circ} 25' 30''$) and running along said northwesterly line of Caspee Street four hundred forty five and $\frac{06}{100}$ (445.06) feet to the intersection of said northwesterly line of Caspee Street and the northwesterly line of Promenade Street;

thence, turning an interior angle of one hundred eight degrees, fifty two minutes, no seconds ($108^{\circ} 52' 00''$) and running along said northwesterly line of Promenade Street three hundred seventy five and $\frac{19}{100}$ (375.19) feet to the intersection of said northwesterly line of Promenade Street and the northeasterly line of Park Street;

thence, turning an interior angle of one hundred five degrees, thirty seven minutes, forty five seconds ($105^{\circ} 37' 45''$) and running along said northeasterly line of Park Street one hundred forty seven and $\frac{67}{100}$ (147.67) feet to an angle point;

thence, turning an interior angle of ninety degrees, no minutes, no seconds ($90^{\circ} 00' 00''$) and running ninety six and $\frac{70}{100}$ (96.70) feet to an angle point;

thence, turning an interior angle of two hundred twenty four degrees, twenty five minutes, twenty seconds ($224^{\circ} 25' 20''$) and running five hundred seven and $\frac{48}{100}$ (507.48) feet to the point and place of beginning.

Said tract herein described contains one hundred eighty eight thousand five hundred twenty nine (188,529) square feet of land, more or less.

It is intended to convey hereby all riparian rights connected with the parcel or tract of land so conveyed.

Section 2. If the said tract or parcel of land or so much of it as may be necessary to effectuate the aforementioned purpose is not devoted to the site of a new railroad station and tracks used in conjunction therewith within ten years of the date of passage of this act, title thereto shall revert to the State of Rhode Island.

Section 3. The Chairman of the Board of Trustees of State Colleges shall execute a deed to effectuate the foregoing. Prior to execution, such deed shall be approved by the Attorney General and by the Board of Trustees of State Colleges as to form and substance.

Section 4. This Act shall take effect upon its passage.

AN ACT

AN AMENDMENT OF CHAPTER 1698 OF THE 1947 PUBLIC LAWS AUTHORIZING A ONE MILLION FIVE HUNDRED THOUSAND (\$1,500,000) DOLLAR BOND ISSUE BY THE CITY OF PROVIDENCE FOR SCHOOL ATHLETIC FIELDS.

It is enacted by the General Assembly as follows:

SECTION 1. Section 1 of Chapter 1698 of the 1947 Public Laws entitled "An Act Authorizing the City of Providence to Issue Bonds in the Amount of \$1,500,000 for the Acquisition and/or Improvement of School Athletic Fields, including the Purchase or Condemnation of Land for such purposes" is hereby amended to read as follows:

Section 1. The city of Providence is hereby authorized and empowered, in addition to and not in substitution for authority previously granted, to issue, in addition to the bonds heretofore issued and now outstanding, under its corporate name and seal, serial bonds in any form, not exceeding \$1,500,000. Said bonds shall be of any denomination not exceeding \$20,000 each, shall bear interest at a rate not exceeding three (3) per centum per annum, payable semi-annually, the principal thereof and the interest thereon shall be payable in any coin or currency of the United States of America, which at the time of payment is legal tender for public and private debts, and the debts incurred by said bonds shall be obligatory on said city in the same manner and to the same extent as other debts lawfully contracted by said city. The dates of maturity of said bonds shall, in no case, be more than twenty-five (25) years after date of issue and not less than three and one-half percent nor more than six and one-half percent of the principal amount of said bonds issued shall become due and payable in any one year, provided, however, that no bonds issued under the provisions of this act shall mature within five years after the date of issuance nor later than the year 1990.

SEC. 2. This act shall take effect upon its passage and all acts or parts of acts inconsistent herewith are hereby repealed.


