# RESOLUTION OF THE CITY COUNCIL

No. 705

Approved November 15, 1999

**WHEREAS**, An Ordinance appropriating \$50 million and authorizing the issuance of \$50 million in bonds for the Neighborhood Improvement Program: A Plan to Revitalize Providence's Neighborhood's was adopted (1997-27); and;

**WHEREAS**, said ordinance requires that "each component of said plan will be developed and approved by the City Council prior to the expenditures of any funds", and;

**WHEREAS**, \$28,680,259.80 million has been appropriated by Council Resolution No. 375 dated June 30, 1997 as well as Council Resolution Numbers 474 dated August 22, 1997, 610 dated October 19, 1997, 702 & 703 dated December 19, 1997, 163 dated March 16, 1998, 258 & 259 dated April 24, 1998, 357 dated June 26, 1998, 555 dated September 28, 1998, 719 dated December 28, 1998, 118 dated February 28, 1999, No. 276 dated May 14, 1999 and No. 486 dated August 16, 1999 for various projects; and;

**WHEREAS**, plans have been developed for additional components of the Neighborhood Improvement Program;

**NOW, THEREFORE, BE IT RESOLVED** that the following expenditures of funds are approved:

1. NEIGHBORHOOD IMPROVEMENT PROJECTS:

A. Ward 1

1. Fox Point Project Area (Trenton & Ives St.) - \$93,500.00
2. Fox Point Elementary School Site Improvements - \$80,000.00
3. Wayland Square Traffic Calming Improvements - \$165,000.00
4. Removal of Diseased Street Trees (additional funds) - \$10,000.00
5. Governor Lippitt Museum (sidewalk repairs) - \$5,000.00
6. Street & Traffic Sign Replacement - \$5,000.00

B. Ward 12

1. Camden Avenue Recreation Center Improvements - \$6,200.00

C. Ward 13

1. West Broadway Traffic Calming Project - \$250,000.00

D. Ward 14

1. 100 General Street Building Renovations (additional funds) - \$100,000.00

E. Ward 8

1. Holy Cross Church of God in Christ - \$10,000.00

F. Ward 10.

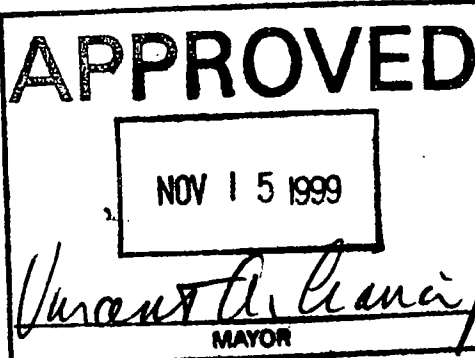

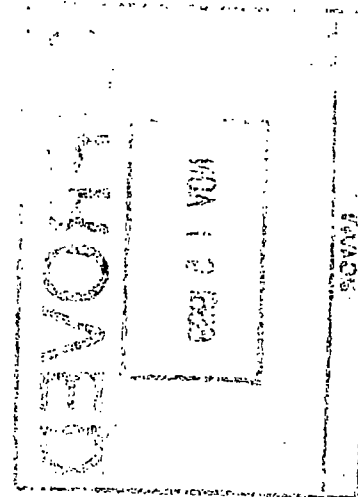

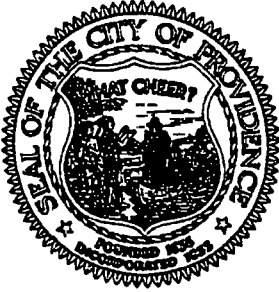
