THE NEW YORK, NEW HAVEN AND HARTFORD RAILROAD COMPANY (hereinafter called the Railroad Company) hereby leases to **the WATER SUPPLY BOARD, CITY OF PROVIDENCE, RHODE ISLAND**

(hereinafter called the Lessee) the

right to install, use and maintain a certain construction, consisting of a 16 inch cast iron water main in a 48 inch concrete casing, with manholes, on, across and under land and tracks of the Boston Division of the Railroad Company from point in the northwesterly property line of the Railroad Company adjacent to Silver Spring Street and about 700 feet southwest of Branch Avenue, in Providence, Rhode Island, southeast about 890 feet to property line of the Railroad Company at West River Street in said Providence, substantially as shown in red on print hereto attached, made a part hereof and entitled: "N.Y.N.H. & H. R.R.Co. Boston Div.-Prov. District Main Line Proposed Relocation Of 16 Inch High Service Main In Vicinity of Branch Avenue Bridge pl. 60 Providence, R.I. Scales As Shown Jan. 24, 1957",

upon the following terms and conditions:

1. The term of this lease shall date from **February 26, 1957**, and shall continue until terminated by a written notice given by either party to the other at least thirty days prior to the date of termination.
2. The Lessee shall pay to the Railroad Company as rent the sum of **Two Hundred and Forty-nine Dollars (\$249.00) per year** on the **twenty-sixth** day of every **February** in advance, during the continuance of this lease (and pro rata for a shorter period), a proportionate part of said rent to be refunded to the Lessee in case of termination hereof by the Railroad Company by notice under the preceding paragraph prior to the date to which rent shall have been paid.
3. The Lessee shall install and maintain said construction to the satisfaction of the Railroad Company and under the Railroad Company's supervision and direction, and, except in case of emergency, shall do no work with reference to the maintenance or repair of said construction on the Railroad Company's premises except under such supervision and direction and after reasonable notice in writing to the superintendent of the division of the Railroad Company on which said construction is located.
4. The Lessee shall reimburse the Railroad Company for any and all expense that may be incurred by the Railroad Company in connection with the installation, maintenance or use of said construction.
5. The Lessee assumes all risk of loss of or damage to property and injury to or death of persons occurring on the premises of the Railroad Company or in connection with the use thereof, and shall indemnify and save harmless the Railroad Company from any and all suits, claims, demands or liens arising out of or resulting from the said loss, damage, injury or death, unless caused by the sole negligence of the Railroad Company, in which event the Railroad Company shall be solely liable; or by the joint negligence of the Lessee and the Railroad Company, in which event they shall be jointly liable and any resulting damage shall be borne by them equally.
6. The Lessee shall not by the installation, maintenance, use or removal of said construction in any way or at any time interfere with the safe passage of the Railroad Company's trains.
7. The Lessee shall on request of the Railroad Company and without expense to it, make such changes in said construction as may be required by the Railroad Company, if such changes shall in the judgment of the Railroad Company be needed in connection with the development or use of the premises of the Railroad Company.
8. On termination of this lease for any cause, the Lessee shall, without expense to the Railroad Company, remove said construction from the premises of the Railroad Company and leave said premises in a condition satisfactory to the Railroad Company.
9. The Lessee shall not assign this lease without the written consent of the Railroad Company.
10. This lease shall be binding upon and inure to the benefit of the legal representatives, successors and assigns of the parties respectively.

It is understood and agreed that the leased premises are owned in part by the Trustees of the property of the Boston & Providence Railroad Corporation whose property is in possession of and operated by the Railroad Company, and that regardless of any other provision contained herein this lease shall terminate, ipso facto, if and when at any time the Railroad Company shall cease to be in possession of that portion of the leased premises owned by said Trustees.
