# RESOLUTION OF THE CITY COUNCIL

No. 266

Approved April 20, 1984

RESOLVED, That the Providence City Council hereby urges the Rhode Island General Assembly to pass the following legislation in addition to legislation endorsed by other resolutions of this Council and previously submitted to members of said General Assembly with resolutions requesting passage:

1. 84-H7512 entitled "An Act Relating to Fees for Weights and Measures in the City of Providence (Condemnation of Incorrect Scales)" or legislation enabling the City Council of the City of Providence to set fees for weights and measures and provide for condemnation of incorrect scales.

2. 84-H7700 entitled "An Act Relating to the Bureau of Licenses of the City of Providence" and/or 84-S0108 entitled "An Act Relating to the Bureau of Licenses in the City of Providence (Fine of up to \$1,000 Issued to Violators of License Issued)."

3. 84-H9332 entitled "An Act Permitting the Town of Lincoln to Tie into the Providence Water System."

4. 84-S0728 entitled "An Act Relating to Public Safety."

5. 84-S289 entitled "An Act Relating to Cities and Towns" regarding penalties for violations of Chapter 45-24.3 entitled "The Housing Maintenance and Occupancy Code."
