**REQUESTING THE GOVERNOR TO TRANSFER CERTAIN LAND
FROM THE CONTROL OF THE STATE DEPARTMENT OF
EDUCATION TO THE DIVISION OF PARKS AND RECREATION.**

**RESOLVED, That His Excellency the Governor be and he is
hereby respectfully requested to transfer jurisdiction and control
of that certain parcel of land owned by the state of Rhode Island,
at Carlise Park, bounded and described as follows:**

**Beginning at a point on the easterly side of Glasgow
Street, thence westerly along the southerly side of
Vespucci Street seven hundred and two and 79/100 (702.79)
feet to a point at the intersection of said Vespucci Street
and Fernando Street; thence southerly along the easterly
side of said Fernando Street four hundred and thirty-eight
and 38/100 (438.38) feet to a point at the intersection
of said Fernando Street and Corina Street; thence easterly
one hundred sixty (160.0) feet, thence northerly sixty and
55/100 (60.55) feet and thence northeasterly four hundred
forty-seven and 46/100 (447.46) feet, along the northerly
side of the said Corina Street to a point at the inter-
section of Glasgow Street and the said Corina Street and
thence northerly along an imaginary line to the point and
place of beginning; a total area of approximately four and
7/10 (4.7) acres;**

**to the division of parks and recreation for development as a recrea-
tional facility; and be it further**

RESOLVED, That His Excellency the Governor be and he is hereby authorized to revert jurisdiction and control of the said land, above described, to the departments of education whenever they deem it necessary and upon request.

MAKING AN APPROPRIATION OF \$10,000 TO BE USED FOR
THE DEVELOPMENT OF RECREATIONAL FACILITIES ON THAT
LAND AT GOWAN PARK WHICH WAS TRANSFERRED TO THE
JURISDICTION AND CONTROL OF THE DIVISION OF PARKS
AND RECREATION.

RESOLVED, That the sum of \$10,000 be and the same hereby
is annually appropriated, out of any money in the treasury not
otherwise appropriated, to be used for the development of recrea-
tional facilities on that land at Gowan Park which was transferred
to the jurisdiction and control of the Division of Parks and Recrea-
tion. The allocation of said sum shall be under the jurisdiction
of the director of public works; and the state controller is hereby
authorized and directed to draw his orders upon the general warrant
for the payment of such sum or sums, or so much thereof as may be
required from time to time, upon receipt by him of proper vouchers
approved by the director of public works.
