# RESOLUTION OF THE CITY COUNCIL

No.325

Approved June 22, 1988

WHEREAS, primary and general elections have been ordered by the United States District Court for the District of Rhode Island for Wards Nine (9) and Eleven (11) for the City Council of the City of Providence to coincide with the 1988 statewide elections.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Providence, Rhode Island that in compliance with the Court's Order the said City Council does hereby order Special Elections to be held in Wards Nine (9) and Eleven (11) to coincide with the 1988 Statewide Elections.

BE IT FURTHER RESOLVED, That the Board of Canvassers and Registration of the City of Providence, Rhode Island, and all other officers whose duty it is to prepare for elections, are hereby requested and notified to make such preparations for said election as required by law, and

BE IT FURTHER RESOLVED, That the City Clerk is directed to cause a certified copy of this Resolution to be transmitted to the Board of Canvassers of the City of Providence Rhode Island; and that a duly certified copy of this Resolution be transmitted to the State of Rhode Island Board of Elections and to the Secretary of State of Rhode Island.


