WHEREAS, The Rhode Island Substance Abuse Prevention Act Legislation Commission recently discovered that there was over \$2.3 Million Dollars available in Funds for the Commission to use, which apparently had not been tapped previously, and

WHEREAS, The City of Providence could benefit substantially as well as the other 38 Cities and Towns in Rhode Island if this money is released, and

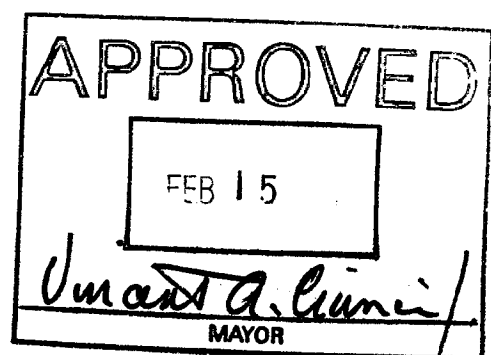
WHEREAS, The only thing now that is needed to release these funds are the signatures of the Governor, the Senate Majority Leader and the House Speaker, and

WHEREAS, The City Council of the City of Providence does hereby request Governor Sundlun, Senate Majority Leader Paul S. Kelly and House Speaker John B. Harwood to release the \$2.3 Million Dollars in funds to the Cities and Towns,

NOW, THEREFORE, BE IT RESOLVED, That if such monies are released, the City of Providence will realize some \$145 Thousand plus Dollars for the City's Task Force, and

BE IT FURTHER RESOLVED, That copies of this Resolution be forwarded to all Cities and Towns within the State, asking that they join with the City of Providence in presenting a unified voice in seeking the release of these Funds.
