KNOW ALL MEN BY THESE PRESENTS:

THAT the CITY OF PROVIDENCE, a municipal corporation, created by act of the General Assembly of the State of Rhode Island, for and in consideration of the sum of THIRTY-FIVE THOUSAND SEVEN HUNDRED SEVENTY-SIX (\$35,776) DOLLARS to it paid by PROVIDENCE AUTOMOTIVE ENGINEERING CO., INC., the receipt whereof is hereby acknowledged, does hereby grant, bargain, sell and convey unto the said PROVIDENCE AUTOMOTIVE ENGINEERING CO., INC., of the City of Providence, County of Providence, State of Rhode Island, in fee simple, the following: (Lot 243, Plat 22);

Beginning at a point in the easterly line of Allens Avenue, said point being the northeast corner of Allens Avenue and Henderson Street; thence running in a northerly direction along the easterly line of Allens Avenue a distance of 177.33 ft. to a point; said point being the northwest corner of the herein described parcel; thence turning an interior angle of $93^{\circ}-16'-00''$ and running in an easterly direction bounded northerly by land now or formerly owned by Narragansett Electric Company, a distance of 159.65 ft. to a point; thence turning an interior angle of $169^{\circ}-05'-34''$ and still running in an easterly direction a distance of 15.47 ft. to a point, said point being the northeast corner of the herein described parcel; thence turning an interior angle of $97^{\circ}-42'-26''$ and running in a southerly direction a distance of 234.33 ft to a point, said point being the southeasterly corner of the herein described parcel and also being a point in the northerly line of Henderson Street; thence turning an interior angle of $74^{\circ}-00'-00''$ and running in a westerly direction along the northerly line of Henderson Street, a distance of 181.99 ft. to the point and place of beginning. This last line, together with the first line herein described, form an interior angle of $105^{\circ}-56'-00''$.

The above described parcel contains 36,222.6 square feet.

TO HAVE AND TO HOLD the same with all the rights, privileges and appurtenances thereof and thereunto appertaining, unto and to the use of the said PROVIDENCE AUTOMOTIVE ENGINEERING CO., INC., at 773 Broad Street, Providence, Rhode Island, its heirs and assigns forever.
