APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR
THE UPPER SOUTH PROVIDENCE REVITALIZATION PROJECT" FOR
ADDITIONAL ACQUISITION.

Be it ordained by the City of Providence:

1.
