Section 1. Chapter 1974-19 of the Ordinances of the City of Providence, as approved June 19, 1974 and entitled: "An Ordinance Making Appropriation of \$85,823,307.71 for the Support of the City Government for the Fiscal Year ending June 30, 1975," is hereby further amended by appropriating Fifty Five Thousand Dollars (\$55,000.00) for the City of Providence Food Stamp Program. Said sum to be transferred to the Revolving Fund and any unspent monies shall revert back to General Fund.
