

During the past fiscal year ending September 30, 1966 the receipts of this office totaled \$66,693.43 in comparison to last year's total of \$78,533.44. Our accounts receivable as of September 30, 1966 stood at \$1,283.26, less than half of last year's.

New cases during the year totaled 977. This is an increase of 23 cases over the preceding year's total of 954 cases. Petitions for probate of will were 475 as against 454 of the preceding year. Petitions for administration increased from 265 to 284; petitions for guardianship were 113 against 115 from last year's. The balance of the new cases were made up as follows: foreign wills 7, administrations in Rhode Island 3, Conservatorships 17, Change of Names 56, and testamentary guardianships 2.

Registry accounts in the sum of \$83,886.17 were established during the year of which \$64,750.32 was deposited for absentees and unknown heirs and \$19,135.85 was deposited for the benefit of minors.



Dear Mayor Doorley:

The Bureau of Licenses submits herewith a report of its activities for the year ending, December 31, 1966.

The Bureau has authorized the issuance of 14,034 licenses of various types.

It has held approximately 146 informal hearings.

In addition, the Bureau conducted 73 formal hearings, to which licensees were summoned by the Bureau for violations of various kinds-violations of the provisions of State Statutes, Ordinances of the City of Providence, or the Rules and Regulations of the Bureau of Licenses.

At these formal hearings, witnesses were summoned-police and other interested parties. In approximately 50% of the violations that were heard, licensees were represented by Counsel. An assistant City Solicitor represented the Bureau. Witnesses were sworn, testimony was taken, both direct and by cross-examination, and subsequently the members of the Bureau, discussed the cases in executive session, after which they announced their decision.

For various reasons, cases were continued from time to time at the request of counsel, illness of licensee or interested parties but usually-and this was a strict rule of the Bureau, licensees and applicants for licenses whose applications were not approved were given prompt hearings.


