



Dear Mike:



Dear Mayor Cianci:

The year 2001 marks the world-wide commemoration of the 1700th year since the adoption of Christianity as the national religion of Armenia. Our community in Providence has discussed a number of ways we in Rhode Island could observe this anniversary and have concluded that renaming the street, currently called Dawson Street, for our homeland would be appropriate. You have always been a true friend of the Armenians in Providence, and we look to you in the hope that you will support and grant this request.

We have agreed that changing the current name to Armenia Street would rightfully recognize Armenia as the first nation to proclaim Christianity as its state religion. The patron saint of the Armenian Apostolic Church, St. Gregory the Illuminator, who was responsible for making Christianity the religion of Armenia, had been imprisoned for fifteen years in Khor Virab until he was released to cure King Tiridates' illness. He eventually converted the king, was ordained in Caesarea, returned to Armenia to baptize the king and the royal family and was installed as the first Catholicos of Armenia. St. Gregory had a vision in Vagharshapat of Christ descending from heaven and striking the ground with a golden hammer. That spot is the site where the Holy See of our church, Cathedral of Etchmiadzin (meaning "the Only Begotten descended"), stands today. For us American Armenians, the street where Sts. Vartanantz Church stands symbolizes the endurance and stability of the Apostolic Church in Providence and world wide.

For this reason, we are once again requesting your assistance in establishing the name *Armenia Street* for the street, now known as Dawson Street, directly behind Sts. Vartanantz Church.
