Gentlemen:

At the request of Council Resolution No. 742, approved December 4, 1953, the traffic engineer has studied the advisability of installing TRAFFIC SIGNAL CONTROL at the intersection of Brook Street and Wickenden Street.

Traffic volume counts made on the 29th of December, 1953, showed the volumes to be sufficiently high enough to warrant the installation of TRAFFIC SIGNAL CONTROL. However, during the three-year period from November 1, 1950 to October 31, 1953, only ten accidents have been reported at this intersection. This accident record can be considered good when compared with other intersections throughout the city that do not yet have traffic control. Therefore, this intersection shall be placed on our tentative list for possible signalization during 1954 but it seems unlikely that signal control will be established within the next year as there are many other locations with a higher priority than Brook Street and Wickenden Street.

Gentlemen:

At the request of Council Resolution #758, approved December 4, 1953, the traffic engineer has studied the advisability of the installation of traffic signal control at the intersection of Hope Street and Olney Street.

Traffic volume counts taken at this intersection showed the volumes to be sufficiently high to justify the installation of traffic signals. However, since STOP signs were erected at this intersection on the 28th of November, 1951, there have been only four accidents reported at this intersection. This is an excellent accident record and one that could not justify the installation of traffic signal control.

This intersection will be placed on our list for reconsideration for traffic signals in the 1954 program but it is seriously doubted that signals will be installed this year because of the high priority of many other locations.

Gentlemen:

At the request of Council Resolution #741, approved December 4, 1953, the traffic engineer has studied the advisability of restricting parking to one side of Camp Street from Olney Street to Rochambeau Avenue.

This section of Camp Street is 30 feet in width and for the amount of parking observed on Camp Street this width should be sufficient to handle this parking and still move traffic in two directions. We are very hesitant to restrict any more parking than is absolutely necessary.

Until such time as the parking demand becomes heavier on Camp Street and there is an apparent hazard caused by such parking, we are sorry to say that we must deny any request for parking restrictions on Camp Street at this time.
