This is to advise your committee that I no longer have an interest in Assessor's Plat 45, Lots 380, 381, 388, 390, 393, and 640. These lots were erroneously conveyed to me as tax-reverted property in June, 1980. Actually, the city has already foreclosed the right of redemption on these parcels, making an assignment of tax title inadequate to convey them to me.

Presumably, the city cleared title on these lots to pave the way for their transfer to OIC. Since they are adjacent to that facility, I feel it would be desirable to transfer them to that organization for a nominal sum.
