No. 613 AN ORDINANCE

IN AMENDMENT OF AND IN ADDITION TO CHAPTER 1977-5 OF THE ORDINANCE OF THE CITY OF PROVIDENCE APPROVED FEBRUARY 14, 1977 AND ENTITLED, 'AN ORDINANCE APPROVING AND ADOPTING THE OFFICIAL REDEVELOPMENT PLAN FOR DOWNTOWN PROVIDENCE RENEWAL.'

Approved October 14, 1994

Be it ordained by the City of Providence:

1. That Chapter 1977-5 of the Ordinance of the City of Providence, approved February 14, 1977 and entitled, "An Ordinance Approving and Adopting the Official Redevelopment Plan for Downtown Providence Renewal" as amended by Chapters 1978-44, 1981-26, 1981-50, 1983-7, 1983-14 and 1993-26 of the Ordinance of the City of Providence, approved November 24, 1978, May 21, 1981, October 23, 1981, February 18, 1983, April 22, 1983 and September 13, 1993 respectfully, be and the same is hereby further amended as follows:
 - A. Attach to Map No. 3B "Detail Map of Acquisition" dated 3-92 the following note:

Existing "gangway" situated northwest of the property to be acquired shall be abandoned and/or condemned in order to become part and parcel of the property to be acquired.
2. That said Chapter 1977-5 of the Ordinance of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other aspects.
3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy therefore to the Providence Redevelopment Agency.

Dear Mr. ^{mike} Clement:

Enclosed is an original and twenty (20) copies of an Ordinance in Amendment to the Downtown Providence Official Redevelopment Plan.

The purpose of this Ordinance is to amend the redevelopment plan to clarify the fact that an existing "gangway" in the project area, adjacent to the proposed "Robert E. Freeman Park" (Formerly Grace Park) was to be condemned and made part of the PRA property as originally intended.

Since this amendment provides for the acquisition of property, the enabling legislation requires that a public hearing must be published not less than once a week for three (3) consecutive weeks. Please notify me of the scheduled date so that we may insert public notices in the Providence Journal and Evening Bulletin.

Councilmen John H. Rollins and David G. Dillon, members of the Providence Redevelopment Agency, requested that this Ordinance be placed on the Docket for the next regular scheduled meeting of the Providence City Council.
