No. 200 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE
CHAPTER 1985-69 APPROVED June 25, 1985 BY TRANSFERRING VARIOUS
SUMS OF MONEY WITHIN VARIOUS DEPARTMENTS, AS AMENDED.

Approved March 21, 1986

Be it ordained by the City of Providence:

SECTION 1. Chapter 1985-69 of the Ordinances of the City of Providence, as approved June 25, 1985, entitled: "An Ordinance making appropriation of One Hundred Eighty Million, Six Hundred Seventy Six Thousand, Thirty Three Dollars and Sixty-Two Cents (\$180,676,033.62) For the Fiscal Year ending June 30, 1986, as amended", is hereby further amended by transferring various sums of money within various departments.
