RESOLVED, DECREED AND ORDERED:

That the following named highways shown as cross-hatched areas on the accompanying plan entitled "Providence, Rhode Island, Department of Public Works-Engineering Office, Street Line Section Map No. 063528, dated December 6, 1971,"

viz:

Bullion Street from the easterly line of South Water Street to the westerly line of South Main Street;

Power Street from the easterly line of South Water Street to the westerly line of South Main Street;

Gold Street from the easterly line of South Water Street to the westerly line of South Main Street;

Silver Street from the easterly line of South Water Street to the westerly line of South Main Street, having ceased to be useful to the public and the same is abandoned as public highways and the damage to the abutters is appraised at nothing and so awarded, and it is further

ORDERED, that the Director of Public Works, be and he is hereby directed to cause a sign to be placed on the above-named highways abandoned as aforesaid, having thereon the words "Not a Public Highway," and it is further

ORDERED, that after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper published in the County of Providence at least once each week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highways which have been abandoned, who is known to reside within this State.

(✓ Bullion Street from the easterly line of South Water Street to the westerly line of South Main Street;


✓ Power Street from the easterly line of South Water Street to the westerly line of South Main Street;


