

RESOLVED, THAT

WHEREAS, the United States of America has heretofore made an advance pursuant to an agreement dated on or about the 2nd day of May, 1946, to the City of Providence in the amount of \$41,000.00 for the purpose of plan preparation of the public work described in the agreement as an administration building, and

WHEREAS, by the use of the Federal advance the City of Providence caused to be prepared plans and specifications for the public work described in the aforesaid agreement, and

WHEREAS, no construction has been undertaken of the project, or any portion thereof, described in the aforesaid agreement dated on or about the 2nd day of May, 1946, and

WHEREAS, there is no reasonable likelihood of the planned project, or any portion thereof, being undertaken because:

(1) The applicant, among other things, purchased another piece of property which it completely remodeled at great expense for the purpose of housing the administration offices of the Water Supply Board of the City of Providence, garaging its equipment, storing its inventory of water meters, pipes, valves, etc. and repairing water meters.

(2) Substantial changes have taken place in the population of the City of Providence and in its community needs.

(3) The Providence Redevelopment Agency, a quasi public corporation, created and operating under the provisions of Title 45, Chapters 31, 32 and 33 of the General Laws of Rhode Island, 1956, as amended, did on the 15th day of May, 1964, take title, by condemnation proceedings, to the site upon which the administration building, herein referred to, was to have been located and did on said date file in the Land Records of the City of Providence a description and plat of the property taken, all in accordance with the provisions of Title 45, Chapters 31, 32 and 33 of the General Laws of Rhode Island, 1956, as amended.

(4) The City of Providence no longer has title to the site upon which said administration building was to have been located.

(5) The administration building, referred to in this project and resolution, was designed for this particular site and no other.

NOW, THEREFORE, be it resolved by the City of Providence that as there is no reasonable likelihood of the project, or any portion thereof, as planned with the Federal advance ever being placed under construction for the reasons set forth above, the Housing and Home Finance Administrator be, and he hereby is, requested to make a determination that the agreement dated on or about the 2nd day of May, 1946, be terminated and that the City of Providence be relieved of all liability thereunder.

This resolution is adopted pursuant to the authority provided by the charter of the City of Providence, Chapter 832 of the Public Laws of 1940, as amended.




