

TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petitions your honorable body

to have the City of Providence, more especially the City Tax Assessor, excuse and exempt us as property owners from paying any and the present Hurricane Barrier Tax as we have been in the same location since 1916 and have never suffered any water damage as a result of the Providence River overflowing; that the farthest that any River water ever came as a result of flooding was up to Richmond Street and we are several hundred feet above Richmond Street.

That the said Barrier Tax is unfair to the petitioners as we are outside the taxing areas and that the water never came onto our property and thus if we are assessed then every piece of property in the Providence area should be assessed even if flood water never reached said property.

That the said tax is unconstitutional and in violation of the Sixteenth Amendment of the U. S. Constitution and Article 1 Section 9 of the Rhode Island Constitution.

RESOLVED, That whereas the City of Providence is spending approximately seven million dollars of federal funds annually, and since the City is contributing 20% of the cost, in kind, for the so-called anti-poverty programs of the Office of Economic Opportunity in the City of Providence, and

WHEREAS, many citizens have voiced concern that the deserving poor are not receiving the necessary help that they are entitled to, and it seems desirable to make an independent evaluation of the program to determine its effectiveness in aiding the poor,

NOW THEREFORE BE IT RESOLVED, That the head of each of the following organizations be asked to appoint a representative to serve as a member of a committee for the purpose of evaluating the anti-poverty program, in light of the above criticism, and report back its findings to the City Council forthwith:

1. R. I. Council of Community Services, Inc.
2. R. I. Dept. of Education (education oriented programs)
3. R. I. Dept. of Social Welfare (welfare supplementary programs)
4. R. I. Dept. of Employment Security and the independent organization of Employment Counselling services.
(job and vocational oriented programs).
