AN ORDINANCE IN AMENDMENT OF CHAPTER 23 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED: STREETS AND SIDEWALKS AND PUBLIC PLACES, AS AMENDED.

Approved June 12, 1987

Be it ordained by the City of Providence:

Section 1. Section 23-63 of the Code of Ordinances is hereby amended to read as follows:

Section 23-63. Place of business prerequisite to licensing.

No license to carry on the business of building or altering sidewalks in the city shall be granted to any person unless he shall have a place of business in the State of Rhode Island.

Section 2. Section 23-64 of the Code of Ordinances is hereby amended to read as follows:

Section 23-64. Fee for License.

The fee for issuing a license to carry on the business of building and altering sidewalks in the city shall be One Hundred (\$100.00) Dollars.

Section 3. Chapter 23 of the Code of Ordinances is hereby amended by adding thereto the following sections.

Section 23-69. Curb cuts - Permit required.

No person firm or corporation shall engage in the alteration of any curb without first filing an application with the director of public works in writing and obtaining a permit therefore. Said permits shall be subject to the approval of the Director of Public Works and the Traffic Engineer. The fee for said permit shall be Fifty (\$50.00) Dollars for residential property and One Hundred Fifty (\$150.00) Dollars for commercial or industrial property.

Section 4. Section 23-70. By whom application is made.

CHAPTER

AN ORDINANCE

Application for a permit shall be made by the licensed person, firm or corporation employed in connection with the proposed work. It shall be accompanied by a duly verified affidavit by the owner or the qualified person making the application that the proposed work is authorized. The full names and addresses of the owner, lessee, applicant, and of the responsible officers, if the owner or lessee is corporate body, shall be stated in the application.

Section 5. This Ordinance shall take effect upon its passage.
