ADDITION TO CHAPTER 1575 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, APPROVED OCTOBER 18, 1963, AND ENTITLED "AN ORDINANCE APPROVING THE OFFICIAL REDEVELOPMENT PLAN FOR THE WEYBOSSET HILL PROJECT NO. R. I. R-7", AS AMENDED, FOR THE REVISION OF BUILDING CONTROLS AND PERMITTED USES FOR PARCEL 7.

Be it ordained by the City of Providence:

1. That Chapter 1575 of the Ordinances of the City of Providence approved October 18, 1963, and entitled "An Ordinance Approving and Adopting the Official Redevelopment Plan for the Weybosset Hill Project No. R. I. R-7" as heretofore amended, is hereby further amended, as follows:
 - A. Section C. LAND USE PLAN, 2. Land Use Provisions and Building Requirements, b. Additional Regulations to be Imposed, (2) Requirements for Specific Reuse Parcels; amend the provisions for Parcel No. 7. to read as follows:
 - All uses permitted by right in a D-1 Zone by the Zoning Ordinances of the City of Providence, adopted June 27, 1994, as amended, shall be permitted.
2. That said Chapter 1575 of the Ordinances of the City of Providence as adopted and as heretofore amended, be and the same is hereby ratified and affirmed in all other respects.
3. That this Ordinance shall take effect on its passage and shall be filed with the City Clerk who is hereby authorized and directed to forward a certified copy thereof to the Providence Redevelopment Agency.

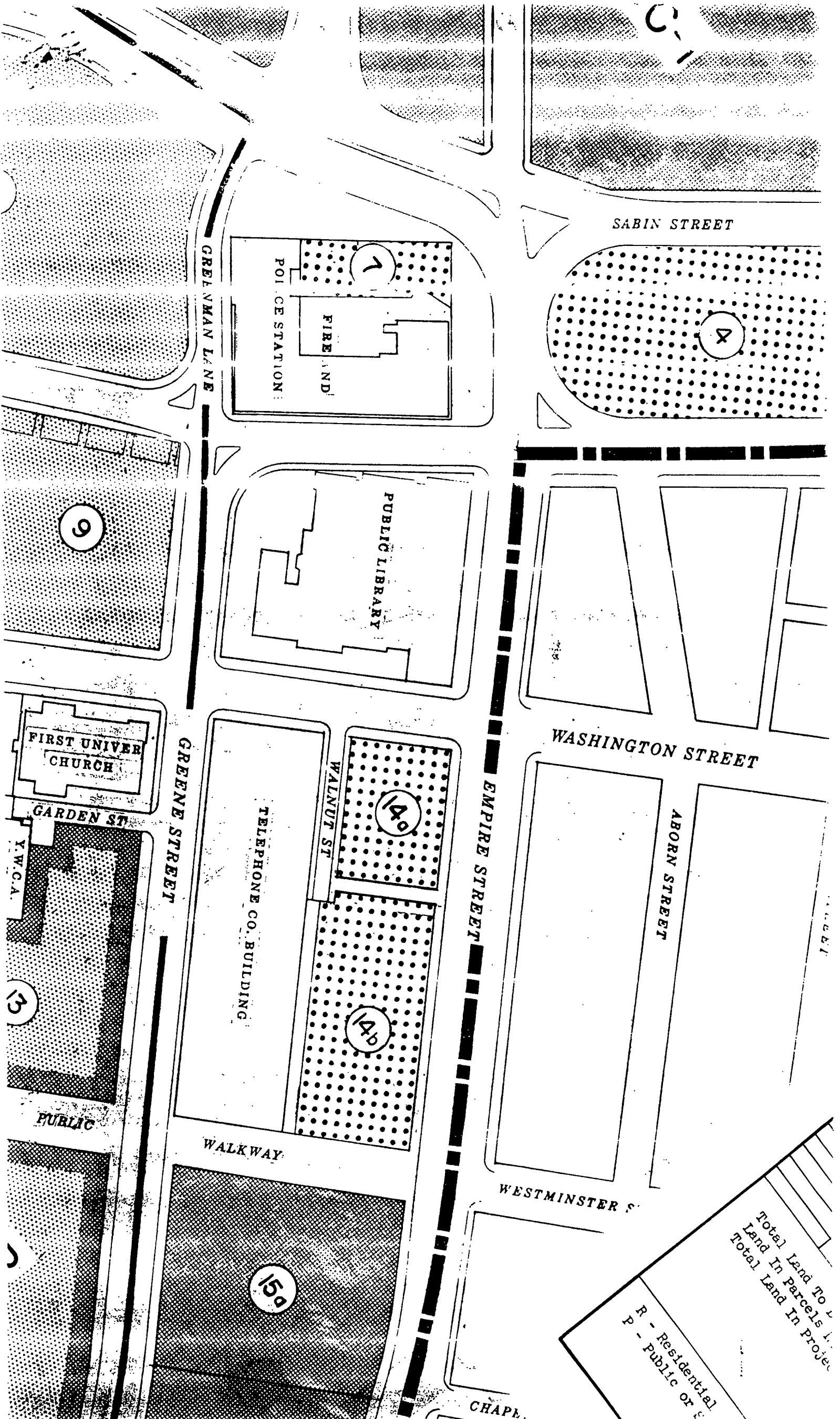
