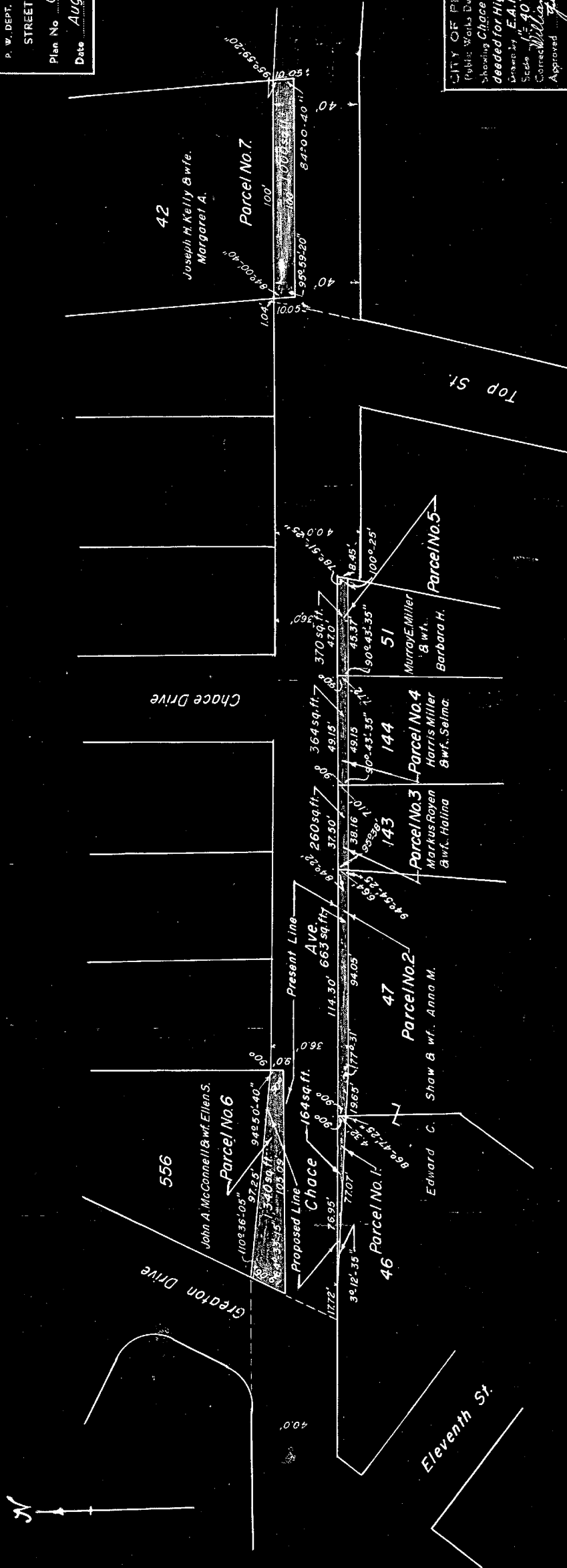


Dear Mr. Cardarelli:
