

With reference to your letter of August 20, 1979, and the certified copy of Resolution Number 710 as approved by the City Council on August 12, 1979, please be advised that I have turned this matter over to our Safety Department for review.

If the said bus stop located at the Broad Street entrance to the Broad Street School is posing a safety hazard, I can assure you that it will be moved; however, I cannot insure that the removal of that sign to 75 feet south in the Washington Park area would be feasible until our Safety Department has had an opportunity to look into this matter.

As soon as the area in question has been reviewed, along with our current policy on bus stop signage, I will contact you with the results.




Dear Ms. Mendonca:
