(EDT) for the purpose of Enacting the following:

- A. An Ordinance providing for the Assessment and Collection of 1998 taxes, being based on One Hundred Percent (100%) of the 1999-2000 Fiscal Year Tax Collection.
- B. An Ordinance making an Appropriation for the Fiscal Year beginning July 1, 1999 and ending June 30, 2000.
- C. An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Ordinance Chapter 1998-35, Approved July 23, 1998.
- D. An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees and the Number of Employees in Certain Classes in the City Departments and Repealing Ordinance Chapter 1998-36, Approved July 23, 1998.

You are therefore, hereby commanded and required to summon each Member of the City Council to that Special Meeting, as Called.




