Be it ordained by the City of Providence:

SECTION 1. Chapter 68-56 of the Ordinances of the City of Providence, as approved September 23, 1968, and entitled: "An Ordinance Making Appropriation of \$53,422,294.21 for the Support of the City Government for the Fiscal Year Ending September 30, 1969", as amended, is hereby further amended by appropriating the sum of Two Hundred Forty Thousand (\$240,000) Dollars to GENERAL PUBLIC ASSISTANCE, ITEM 2.

SECTION 2. The estimated receipts from Grants-in-Aid (State of Rhode Island) General Public Assistance are hereby increased by the sum of Two Hundred Forty Thousand (\$240,000) Dollars.

Now Therefore Be It Resolved That In recognition of the sacrifice of his youthful life, His Honor Mayor Joseph A. Doorley, Jr. and the Members of the City Council, by their approval of this Resolution, hereby designate the corner Atwells Avenue and Leah Street, as "Lance Corporal Frank J. Brosco Memorial Square", to perpetuate the name of a native of the City of Providence, who served with valor and layed down his life as a leader of a group of the 1st Recon Bn of the 1st Marine Division operating in Vietnam on June 21, 1969 and

RESOLVED, that the City Treasurer, acting under the direction of the Committee on finance, be, and he hereby is authorized and directed to borrow from time to time such sums as may be necessary, not exceeding FIFTEEN MILLION (\$15,000,000) DOLLARS, in accordance with the provisions of Chapter 220 of the Public Laws passed by the General Assembly at its January Session, A.D. 1968, and approved June 18, 1968, entitled "An Act Authorizing the City of Providence to Issue Bonds in An Amount Not Exceeding Fifteen Million (\$15,000,000) Dollars for Redevelopment Purposes", and to issue the City's notes therefor, signed by him and countersigned by the Mayor and Chairman of the Finance Committee; and to renew any such notes from time to time as the same become due. The money thus obtained is hereby appropriated for and shall be exclusively used and expended for redevelopment purposes.
