Dear Mr. Clement:

We have received the City Council resolution to clean the area located under the I-95 Overpass near the National Lumber Company on Pilsudski Street in Olneyville.

The Department of Environmental Management's OSCAR program has awarded five Youth Litter Corps grants to non-profit organizations in Providence to hire youth Clean Teams to collect litter for eight weeks starting July 1. The organizations are Keep Providence Beautiful, Nickerson House, Providence Community Action, Smith Hill Center and Southside Community Landtrust.

The Department is meeting with representatives of these agencies next week to coordinate city-wide cleanup schedules and locations, to identify priority areas and to establish sites/areas for joint cleanups and outreach work. The Pilsudski Street area will be included in this meeting as a priority area.

In addition, I suggest that you contact Keep Providence Beautiful (KPB) to assist with maintaining the site beyond the Youth Litter Corps season. KPB organizes community cleanup activities and works with local business to adopt sites in Providence.




