
AN ORDINANCE IN AMENDMENT OF CHAPTER 27 OF THE ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED: "THE CITY OF PROVIDENCE ZONING ORDINANCE", APPROVED JUNE 27, 1994, AS AMENDED, TO CHANGE CERTAIN TEXT IN ARTICLES I, III, IV, V, VI, VII, X AND APPENDIX A TO REVISE THE REGULATIONS FOR DOWNTOWN; AND TO REVISE THE ZONING MAP FOR DOWNTOWN, AS AMENDED.
