Be it ordained by the City of Providence:

SECTION 1. Chapter 1982-60 of the Ordinances of the City of Providence, entitled: An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Chapter 1982-43", approved December 10, 1982, as amended is hereby further amended as follows:



Dear Mrs. Brassil:

Changing the salary of the City Solicitor from \$35,000 to \$42,500 per year will cost the City of Providence \$3,871.90 including FICA and longevity on an annualized basis. Changing Personnel Director from grade 26 to \$30,800 per year will cost the City of Providence \$5,773.70 on an annualized basis including FICA and longevity.
