RE: Request for Abatement of Taxes

With regard to the request of the Mt. Hope Neighborhood Association for the abatement of \$1,524.46 in taxes assessed against assessor's plat 6, lot 514, for the 1984 tax year, I would like to recommend that the organization be advised to file the necessary request for tax exempt status with the Office of City Assessor before any decision is made as to the outstanding 1984 taxes.

Records in the Assessor's office indicate that the property remained in their name as of the December 31, 1984 assessment date, thereby making them liable for a 1985 tax bill as well. Should we abate the 1984 taxes, it can be assumed that the organization would be back to us some time in the near future to have the 1985 taxes abated as well.

Normal procedure with non-profit agencies is to require them to file an application, submit copies of their articles of incorporation, charter, income and expense statements, their IRS and State of Rhode Island tax exempt certificates, to have the property reviewed to ensure that the purposes to which the property is put conforms with R. I. General Laws 44-3-3 allowing tax exempt status.

If the organization can meet these requirements, and based upon the full review I could then recommend the abatement of the back taxes.

It is enacted by the General Assembly as follows:

1           SECTION 1. The Mount Hope Neighborhood Association, a  
2 nonbusiness corporation, incorporated under the general laws of this  
3 state is hereby authorized to take, hold, transmit and convey real,  
4 personal and mixed property, which real, personal and mixed property  
5 is hereby exempt from taxation so long as said property is used for  
6 the purpose for which said corporation is incorporated.

7           SECTION 2. This act shall take effect upon passage.
