





Subject: Board-up Liens at 503 Prairie Avenue

I have reviewed the file for 503 Prairie Avenue. At the present time the City has spent \$529.50 boarding this building since it first became vacant in July of 1976. The total amount due, including interest to March 1st, amounts to \$725.57. The discrepancy in the total amount that I have quoted and the amount in the resolution is caused by an additional boarding up of a door at this property approximately 3 weeks ago.

Since this property has already been demolished and a new low income housing is being constructed on this property, part of which is financed by the City of Providence, I see no reason in requiring the applicant to return money to the City in the form of boarding liens. I, therefore, have no objection to the waiving of these liens.
