RESOLUTION OF THE CITY COUNCIL

RESOLUTION APPROVING ADMIRAL TERRACE ROADS AS PUBLIC RIGHTS-OF-WAY

WHEREAS, the Providence Housing Authority has been the recipient of Federal funds for modernization; and,

WHEREAS, approximately \$15.0 million of these modernization funds have been expended and/or allocated to the Chad Brown/Admiral Terrace Housing Development; and,

WHEREAS, the City of Providence municipal government has an interest in promoting decent, safe, sanitary, and affordable public housing for low-income residents; and,

WHEREAS, the City of Providence has executed a Cooperative Agreement with the Providence Housing Authority, which - among other things - provides for the same level of municipal services provided other citizens of the city;

NOW, THEREFORE, be it resolved by the City Council of the City of Providence that the roadway through Admiral Terrace be accepted as a public right-of-way.

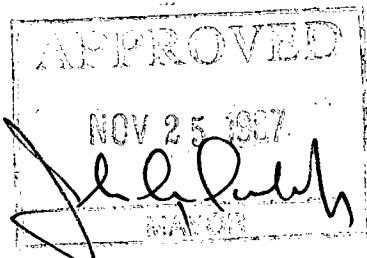



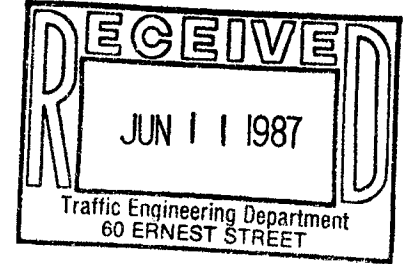

The City of Providence, Department of Public Works, reserves the right to on-going inspection while construction is being undertaken.

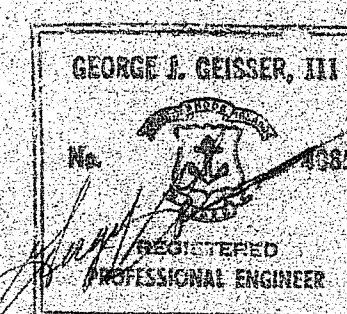
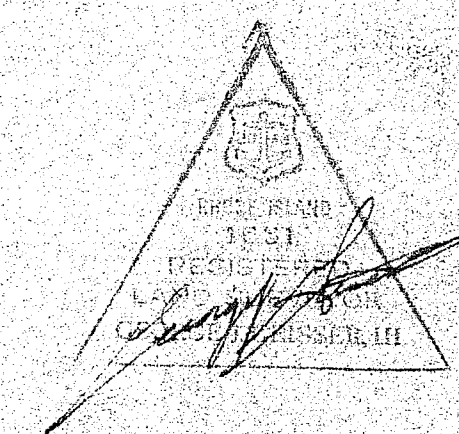
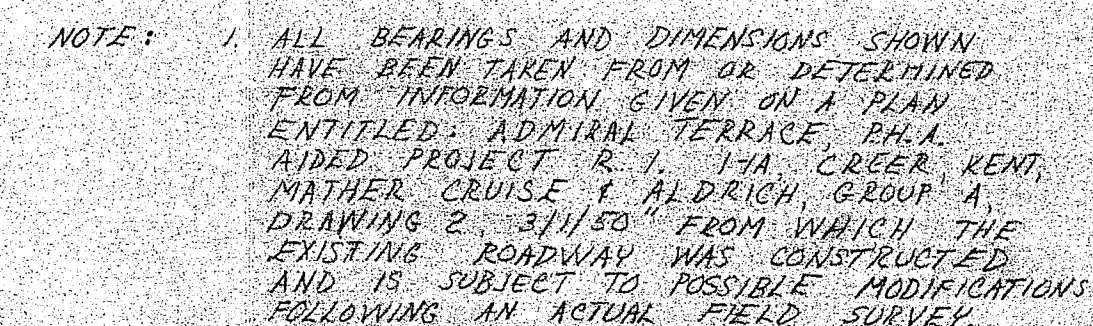
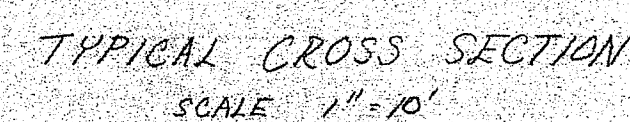
