Be it ordained by the City of Providence:

SECTION 1. Chapter 1984-55 of the Ordinances of the City of Providence, as approved July 20, 1984, as amended, is hereby further amended to read as follows:

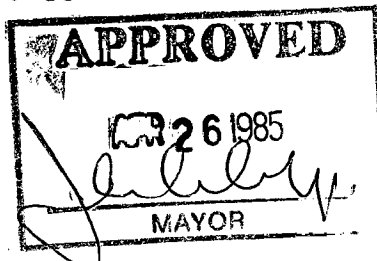
